Question on Notice No. 293 Asked on Tuesday, 22 March 2011

MR KNUTH ASKED THE MINISTER FOR POLICE, CORRECTIVE SERVICES AND EMERGENCY SERVICES (MR ROBERTS)—

What was the total operating budget and expenditure for each correctional facility in Queensland for 2008-09, 2009-10 and 2010-11 year to date (reported separately by year and for each facility) and what was the total cost per prisoner per day for each facility (reported separately by year)?

ANSWER:

The total operating budget and expenditure for each correctional facility in 2008-09, 2009-10, and 2010-11 to 31 March 2011, is summarised in the table provided, using the same financial counting rules for the calculation of 'facility based containment services' in the Queensland Government Service Delivery Statements (SDS).

This information is readily available to Members as a state-wide figure.

The total cost per prisoner per day, for each correctional facility in 2008-09, 2009-10, and 2010-11 to 31 March 2011, is summarised in the table provided, using the same financial counting rules for the calculation of 'cost of containment per prisoner per day' in the SDS.

Low numbers of female prisoners in 2010-11 at Brisbane Women's have accounted for higher per prisoner per day costs to date.

Lower numbers of low security prisoners in 2010-11 have accounted for higher per prisoner per day costs at Capricornia, Darling Downs, Numinbah and Palen Creek.

A decrease in prisoner numbers in 2009-10 at Woodford accounted for higher per prisoner per day costs.
