MRS CUNNINGHAM asked the Minister for Transport and Main Roads (MR EMERSON)—

QUESTION:

With reference to the ministerial response to the Travelsafe Committee Report No.48 that supported the committee recommendation that QR complete a safety case prior to moving to 12 hour shift rosters at any Queensland depots—

- (1) How many safety audits have been completed since the response was tabled on 1 October 2007 and at which depots?
- (2) Which depots did not change shift rosters as a result of the safety case?
- (3) What was the result of the safety case for Callemondah?

ANSWER:

I thank the Member for Gladstone for the question.

(1) With regards to the Travelsafe Committee Report No.48 and the rail safety case QR Ltd provided to justify the change in shift length from 11 hours to 12 hours, Transport and Main Roads' Rail Safety Regulator rolled out an extensive audit program to monitor fatigue management practices.

The Rail Safety Regulator completed a total of 21 audits between March 2008 and July 2012, targeting different railways and various divisions and worksites within the major commercial railways, including QR Ltd's Mackay and Callemondah depots (details tabulated in Attachment A). An additional four fatigue audits are scheduled to be completed in upcoming months.

In general, the rail safety audits identified that risk management strategies are effective in managing fatigue levels. No recommendations are outstanding from these fatigue audits.

(2) Since the initial safety case in 2007, the rail industry has implemented a change from 11 hour to 12 hour shifts for some rail safety workers. This change allows for additional recovery time allocated in weekly rosters. Risk management strategies have been implemented by railways to ensure that fatigue is being adequately managed and 12 hour shifts do not increase the risk of an accident at work or travelling to and from work.

QR Ltd has implemented this change across Queensland including Callemondah.

(3) The Callemondah Depot now operates on a 12 hour roster for coal train drivers. QR Ltd has implemented risk management strategies to the satisfaction of the Rail Safety Regulator.
