

## **Question on Notice**

**Asked on 5 June 2013**

**MR HOLSWICH ASKED THE TREASURER AND MINISTER FOR TRADE (MR NICHOLLS)—**

### **QUESTION:**

What is the Newman Government doing to support families in Pine Rivers to purchase their own home and, in particular, how is it supporting first home buyers?

### **ANSWER:**

The Government has reinstated the principal place of residence transfer duty concession (home concession), providing assistance of up to \$7,175 for eligible homebuyers, ensuring that people buying their own home, such as families in Pine Rivers, do not pay as much duty as investors. In the first nine months of reinstatement, approximately 34,000 home concessions have been claimed.

First home buyers do not pay any transfer duty on homes valued up to \$500,000 and can access concessional duty rates for homes valued between \$500,000 and \$550,000. Under the concessional rates first home buyers can pay up to \$15,925 less than a non-first home buyer paying the standard rate of duty.

To provide a boost to the construction sector, while making it easier for people to buy a home, the Great Start Grant (previously known as the First Home Owner Construction Grant) provides \$15,000 for first home buyers who buy or build a new home.

To increase awareness and uptake of the grant the Government launched a new website and exciting new advertising campaign, aimed at promoting the advantages of the grant.

The table below provides the number of grant payments made each month and a cumulative total, which demonstrates how the number of monthly payments has increased since the grant was first introduced as momentum builds, and eligibility criteria are satisfied.

The ramp up in the number of payments partly reflects, for contracts to build a home, applicants not being eligible to receive payment until either completion of construction or, in the case of applicants applying through a financial institution, until the first draw down of funds has occurred.
