MR JUDGE asked the Attorney-General and Minister for Justice (Mr JARROD BLEIJIE) –

QUESTION:

Will the Attorney-General confirm whether all submissions received at his Ministerial office in relation to the Youth Justice and Other Legislation Amendment Bill 2014 were made public before the Bill was debated and passed, and if not, explain why all submissions were not disclosed in an open, transparent and accountable manner?

ANSWER:

I thank the Member for Yeerongpilly for his question.

I refer to my response to Question on Notice No. 265 (**Attachment 1**), asked by the Member for Yeerongpilly on 3 April 2014. As the Member for Yeerongpilly is aware, the Queensland Parliament requested that the Legal Affairs and Community Safety Committee (the Committee) hold a public inquiry (the Inquiry) into the Youth Justice and Other Legislation Amendment Bill 2014 prior to it being enacted as legislation on 28 March 2014.

As part of the Inquiry, the Committee received 25 submissions and eight supplementary submissions from a range of individuals and organisations. All submissions received by the Committee, as well as the Queensland Government's detailed responses to the issues raised in the submissions, were published on the Queensland Parliament's website prior to the Bill's debate and before the Bill was passed.

A public hearing was held on 3 March 2014 as part of the Inquiry. At the hearing, nine organisations and individuals were invited to discuss their submissions at greater length.

I am satisfied that this open and transparent Inquiry process afforded a reasonable opportunity for all interested parties to make their views on the Bill publicly known and for Members of the Queensland Parliament to consider these views ahead of their participation in the official debate.
