509 MS TRAD ASKED THE MINISTER FOR SCIENCE, INFORMATION TECHNOLOGY, INNOVATION AND THE ARTS (MR WALKER)—

Will the Minister outline grant and operational funding provided to arts and cultural organisations supported by his portfolio, broken down by organisation, for the last three financial years as well as a forecast for the financial year ahead?

ANSWER:

Arts Queensland provides both grant and operational funding to arts and cultural organisations.

Details of grant recipients can be found on the Arts Queensland (http://www.arts.qld.gov.au/funding/funds-outcomes.html) and Open Data (https://data.qld.gov.au/) websites.

It should be noted that each grant program may operate in different ways, with some programs being offered on a calendar year basis, whereas others may be on a financial year basis. This will mean that although a calendar year grant program may have the same level of funding from year to year, the actual grant expenditure paid in each year may vary due to the timing of payments around the end of the financial year.

Awarding a grant occurs when an application is deemed successful and a contract is entered into. Each contract can in some cases split funding into several payments according to milestone deliveries, which can mean that the payments of the grant may spread over more than one financial year.

Operational funding to Arts Statutory Bodies can be found in the Budget papers for the relevant financial year – http://www.budget.qld.gov.au/previous-budgets/index.php.

The Service Delivery Statement (http://www.budget.qld.gov.au/current-budget/budget-papers/bp5.php) provides details on the 2014-15 financial year.

Attachment 1 provides a high level breakdown of 2014-15 budgeted grant allocations across the main grant programs. These will be subject to change during the year, but give a reasonable estimate of budgeted amounts available for each grant program. The Organisations Fund being triennial in nature has been awarded in 2014 for the full three years 2014-16. Therefore it is possible to split out into the required level of detail and this has also been provided in this attachment.

2014-15 budget figures cannot be completely broken down into the requested level of detail. As previously advised in other Questions on Notice, this is due to the budget total being an allocation based on the best information available during the budget preparation time and in most cases the actual grant funding has yet to be awarded to recipients. Some grant programs are competitive in nature, which means that there are specific timeframes when the grant fund may have an application round open, and it is only once applications have been reviewed and assessed that funding will be allocated and payments made to the successful recipients.
