Question on Notice No. 74 Asked on 15 February 2017

MR MCARDLE asked the Minister for Health and Minister for Ambulance Services (HON C R DICK) –

With reference to the specialist outpatient department at Caboolture Hospital-

Will the Minister advise the number of category 1, category 2 and category 3 patients waiting longer than clinically recommended times to see a specialist in relation to (a) cardiology, (b) endocrinology, (c) gastroenterology, (d) non subspecialty medicine, (e) non subspecialty surgery, (f) gynaecology, (g) maintenance care, (h) obstetrics, (i) respiratory medicine or (j) rheumatology services, as at 30 June 2016, 31 December 2016 and to the date of the answer to this question with each service, category and date reported separately?

ANSWER:

I thank the Honourable Member for Caloundra for his question.

On coming to office, the Palaszczuk Government announced an investment of \$361.2 million over four years to address the list of those waiting longer than clinically recommended for a specialist outpatient appointment. In February 2015, the number of people on this 'waiting list for the waiting list' was 104,114. As at 1 May this year, the number had fallen to 50,033 -despite an annual increase in referrals of almost 10%.

I am advised by the Metro North Hospital and Health Service (the HHS) that concerted efforts to reduce long waits at Caboolture Hospital are underway. Based on the anticipated results of these initiatives, by 30 June 2017 I wish to advise the following:

While the performance in most areas is satisfactory, the HHS has advised that significant pressures still exist in the area of Gastroenterology. Efforts to reduce long waits in Gastroenterology have been frustrated by, (a) a major increase in the number of new referrals received, and (b) delays in recruitment and then an unexpected resignation of a second specialist gastroenterologist for this service. However, recruitment of a replacement is well advanced and a new specialist is expected to commence early in the 2017-18 financial year.
