Question on Notice No. 438 Asked on 2 May 2018

MR SJ KRAUSE ASKED MINISTER FOR POLICE AND MINISTER FOR CORRECTIVE SERVICES (HON M RYAN)—

QUESTION:

With reference to complaints against police—

Will the Minister advise (a) how many and what nature of complaints were received in 2015-16, 2016-17 and 2017-18 (reported separately), (b) how many were summarily dismissed, (c) how many were resolved by internal resolution, with the Crime and Corruption Commission or by external prosecution and (d) what were the outcomes (reported separately by type)?

ANSWER:

I am advised by the Queensland Police Service (QPS) that the below table reflects the nature and number of complaints in 2015-16 and 2016-17.

The QPS has advised that 2017-18 figures are yet to be finalised.

It is important to note there are millions of interactions a year between police and the community. For instance, there are on average 1.5 million interactions a year between police and the community of Gold Coast alone. I am further advised that the vast majority of these interactions result in positive feedback about police conduct.

The Queensland Police Service advises that complaints made against members of the Queensland Police Service are resolved in a number of ways, including:

- The police discipline process after the finalisation of any criminal matters
- a complaint against the officer / staff member is unable to be substantiated
- the officer / staff member is exonerated; and

no further action is required.

The QPS has advised that the number of complaints finalised in 2015-16 and 2016-17 are outlined as follows:
