MR A PERRETT ASKED MINISTER FOR AGRICULTURAL INDUSTRY DEVELOPMENT AND FISHERIES (HON M FURNER)—

QUESTION:

With reference to animal welfare in Queensland—Will the Minister outline the number of (a) prosecutions for animal welfare offences, (b) individuals charged with animal welfare offences, (c) offences involving livestock and (d) animals confiscated or temporarily seized as a result of animal welfare concerns (reported separately for 2015 to 2019)?

ANSWER:

The Palaszczuk Government is committed to providing high standards of welfare for animals in Queensland. The *Animal Care and Protection Act 2001* (ACPA) is the principal legislation that regulates the welfare of animals in Queensland. One of the purposes of ACPA is to provide standards of care that achieve an appropriate balance between the welfare of animals and interests of persons whose livelihood is dependent on animals. ACPA is administered by the Department of Agriculture and Fisheries (DAF), and jointly enforced with the RSPCA.

Where appropriate, DAF will work with people to ensure the welfare standards for animals can be met. Where this is not possible, stronger action such as the seizure of animals and prosecution for breach of animal welfare standards are options under ACPA.

The Queensland Government has recently committed funding of \$4.7 million to ensure the DAF can implement the recommendations from the Inquiry into animal cruelty in the management of retired Thoroughbred and Standardbred horses in Queensland (the Martin Inquiry) including developing new codes of practice to ensure horses are treated humanely at slaughtering facilities and in their transport to those facilities.

The funding will also provide enhanced training for animal welfare inspectors and enhanced compliance monitoring, investigation and reporting.
