**MR J BLEIJIE ASKED MINISTER FOR HOUSING AND PUBLIC WORKS; MINISTER FOR DIGITAL TECHNOLOGY; MINISTER FOR SPORT (HON M DE BRENNI)**

With reference to public housing properties located on the Sunshine Coast, as of 30 January 2020—

Will the Minister advise the number of vacant properties and the number of days each property, reported separately, had been vacant since the previous tenants vacated the property?

**ANSWER**

As at 31 January 2020 there are 2,471 government owned and managed properties in the Sunshine Coast LGA.

A total of 11 properties available for reletting were vacant as at this date. Of these, all were vacated and are undergoing, or have undergone vacant maintenance.

Vacant maintenance is performed in accordance with the Department of Housing and Public Works' Vacant Maintenance Policy with the works performed to provide the incoming tenant with a property that is fit to live in, is in good repair and provides a healthy, secure and safe home, in the shortest possible time.

The department manages its vacant maintenance to ensure people in high housing need receive timely assistance and to minimise financial costs through loss of rent. Where possible, maintenance work is undertaken within benchmarked timeframes to reinstate the property to a lettable standard.

A table showing the number of days each property had been vacant is reported below.
