MR S MINNIKIN ASKED MINISTER FOR TRANSPORT AND MAIN ROADS (HON M BAILEY)—

QUESTION:

Will the Minister provide for 2018–19 to 2020–21 (reported separately by financial years and offence type) the number of (a) Camera Detected Offence Program and tolling fines issued and (b) fines where the recipient has elected to have the matter heard by a court and (i) the court upheld the fine, (ii) the court dismissed the fine, (iii) the government has not taken the matter to court and (iv) the matter is still before the court?

The table below outlines the infringement notices issued by type and financial year.

¹ This figure includes direct court-elections and matters where the fines have been referred to the State Penalties Enforcement Registry, however the defendant has completed an application to cancel enforcement order and the infringement notices are then referred to TMR.

² This figure includes infringement notices that have been re-issued at the defendant's request so that payment can be made.

It is important to note that TMR prosecute registration and Compulsory Third Party insurance offences only. Queensland Police Service prosecute CDOP offences relating to speeding and failure to stop at a red light.
