MR M BERKMAN ASKED MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR FIRE AND EMERGENCY SERVICES (HON M RYAN)—

QUESTION:

With reference to juveniles detained in police watch houses in Queensland— Will the Minister advise (a) how many distinct young persons were detained in police watch houses (reported separately by age and Indigenous status) from November 2020 to date for (i) less than 6 hours, (ii) one night (6-48 hours), (iii) 2-6 nights and (iv) more than 1 week, (b) (reported separately by age) how many instances of seclusion were used in watch houses from 1 July 2020 to 30 June 2021 and for how many days and (c) (reported separately by age) how many detained in watch houses from 1 July 2020 to 30 June 2021 and for how many days and (c) (reported separately by age) how many distinct young persons were detained in watch houses from 1 July 2020 to 30 June 2021 for (i) serious indictable offences, (ii) indictable only offences and (iii) summary offences?

ANSWER:

The Queensland Police Service (QPS) has provided the following table in response:

7. The calculations are based on the number of hours between the custody start date and custody end date:

Less than 6 hours: 0 to 5 hours;

Two to six nights: 49 to 168 hours;

More than one week: greater than 169 hours.

8. A person in custody for different durations will only be counted once in each of the time periods.

(b)

I am advised by the QPS that seclusion is not a term used by the QPS. The QPS has advised that, from time to time, some youth offenders may need extra care and support while in custody. In these instances, the QPS has advised that a youth offender may be placed under observation to allow for the provision of that extra care and support. Due to the way that data is recorded, the QPS has advised that to identify all of the instances where this extra care and support has been provided would require a manual examination of all relevant data records. The QPS advises that this manual examination is considered an unjustifiable use of police resources at this time. The QPS has provided the following information regarding the number of juveniles detained in a watchhouse for indictable offences only or indictable and non-indictable offences. Again, due to the way that data is recorded, the QPS advises that to separate the data for serious indictable offences from the data for indictable offences would require a manual examination of all of the charges for every juvenile detained in a police watchhouse. The QPS advises that this manual examination is considered an unjustifiable use of police resources at this time.

A person with multiple custody reports during the period may be counted multiple times in the breakdown but will be counted once in the total for the person's age.

5. Only persons whose age have been identified has been shown.

6. Indictable only refers to charges linked to the arrest/custody report where all of the charges have been flagged as indictable.

7. Both indictable and non-indictable refers to charges linked where some of the charges have been flagged as indictable.

8. To determine if a charge was for a serious indictable offence would require manually verifying each record, requiring significant police resources.
