MR D JANETZKI asked the Minister for Children and Youth Justice and Minister for Multicultural Affairs (HON L LINARD)—

## QUESTION

Will the Minister advise (a) the names of the 20 licensed residential care service providers in the South West region, (b) the number of placements each of the named providers are funded for (reported separately) and (c) the total annual funding given to each?

## **ANSWER**

The Department of Children, Youth Justice and Multicultural Affairs funds residential care services through two different funding approaches:

- Outsourced Service Delivery (OSD) funding: a long-term contract spanning multiple years with payment made to the supplier a quarter in advance. These long-term contracts may be funded for a single residential care site or consolidate a number of residential care sites under one contract.; and
- Fee for Service funding: time-limited arrangements for specific children identified as having particular care and support needs that cannot be provided through contracted outsourced service delivery. Payment is made after services have been delivered.

Of the 20 licensed residential care service providers in the South West Region, eight organisations are subject to both OSD and fee for service funding; six are subject to OSD funding only; and six are funded for fee for service only. A breakdown of the organisations can be found in the table below.
