MR J LISTER ASKED MINISTER FOR TRANSPORT AND MAIN ROADS (HON M BAILEY)—

### QUESTION:

Will the Minister list the number of departmental employees as of March 2022 broken down by Australian and New Zealand Standard Classification of Occupations code and for each (a) the occupation code description, (b) whether it is a frontline, frontline support or corporate service role and (c) if the data for this role was provided to the Public Service Commission?

### ANSWER:

I thank the Member for Southern Downs for the question.

The Australian and New Zealand Standard Classification of Occupations (ANZSCO) provides the basis for the standard for all occupational data across Australia and New Zealand. This classification structure can be found on the Australian Bureau of Statistics website (<https://www.abs.gov.au/statistics/classifications/anzsco-australian-and-new-zealand-standard-classification-occupations/latest-release>), which provides descriptions for each ANZSCO code.

A full list of information relating to the ANZSCO codes for each position within the Department of Transport and Main Roads (TMR) is provided in the table below. All of these ANZSCO codes were provided to the Public Service Commission in the March 2022 quarter's Minimum obligatory human resource information (MOHRI) submission apart from one – ICT Business Development Manager, as the ANZSCO code for this role was changed, prior to the generation of the MOHRI extract.
