MR T NICHOLLS ASKED MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR FIRE AND EMERGENCY SERVICES (HON M RYAN)—

QUESTION:

With reference to the commencement of the Serious and Organised Crime Legislation Amendment Act 2016 in March 2017—Will the Minister advise since March 2017 (reported separately by year) (a) the number of consorting warnings issued, (b) the number of persons charged with habitual consorting, (c) the number of persons charged with the circumstance of aggravation for being part of a criminal organisation and (d) the number of OMCG participants that have been charged with offences and the total number of offences?

ANSWER:

Queensland has the strongest, toughest, most comprehensive anti-bikie gang laws in the nation.

The Queensland Police Service (QPS) advise there has been around a 9.25% reduction in OMCG membership in Queensland since 2015, while across Australia, there has been an increase.

I am advised by the QPS that the data requested by the Member is detailed in the tables below:
