QUESTION:

With reference to Queensland's Land Restoration Fund applications—

Will the Minister advise the total hectares of land in Queensland for which Land Restoration Fund applications have been made (reported separately by year of application, the number of hectares involved for each application and the project location)?

ANSWER:

I thank the Member for the question.

The Palaszczuk Government has delivered on its commitment to establish the Land Restoration Fund (LRF) to develop Queensland's carbon farming industry.

The LRF is recognised by the Carbon Market Institute as the leading carbon farming program in Australia. The LRF is growing Queensland's carbon farming industry, generating new jobs and income streams for rural and regional communities, and delivering valuable environmental and social outcomes.
