MR S O'CONNOR ASKED MINISTER FOR TRANSPORT AND MAIN ROADS (HON M BAILEY)—

QUESTION:

With reference to the Gold Coast Waterways Authority's management of the Gold Coast's waterways and the Minister's responsibilities overseeing vessel registrations—

Will the Minister provide (reported separately by year for the last five years) any data outlining the number of (a) commercially registered vessels, (b) recreational registered boats and (c) recreational registered jet skis who use the waterways of the Gold Coast and (d) vessels which have been issued with infringements by the GCWA for overstaying or breaching buoy mooring, anchoring compliance or oil pollution regulations on the Gold Coast waterways?

ANSWER:

I thank the Member for Bonney for the question.

- (a) This is a matter for the Australian Maritime Safety Authority (AMSA), as the national regulator responsible for the regulation of domestic commercial vessels under a single, national system.
- (b) The number of recreational registered boats, over the last five years, where a Gold Coast postcode or suburb has been recorded by a registrant are outlined in the table below.

It should be noted that while these numbers report vessels where a Gold Coast postcode or suburb has been recorded, use of the Gold Coast waterways by vessels outside of the Gold Coast is common.

(c) Recreational registered jet skis, or personal watercraft, over the last five years, where a Gold Coast postcode or suburb has been recorded by a registrant are outlined in the table below.

GCWA does not usually issue infringements for buoy mooring offences or contraventions of anchoring restrictions. Rather, GCWA takes action for buoy moorings through directions and show cause notices, and issues 'removal notices' for those vessels that overstay anchoring rules. There are no fines associated with these kinds of compliance responses, however, there are requirements on the owner to pay costs associated with either buoy mooring or vessel removal, as deemed under relevant transport legislation.
