# Question on Notice No. 67 Asked on 23 February 2022

Mr D Crisafulli asked Premier and Minister for the Olympics (Hon. A Palaszczuk)—

#### QUESTION:

With reference to the Premier's commitment to appoint Directors-General through a merit based process—

Will the Premier (a) name the members of the independent recruitment panel(s) established for the appointment of Rachel Hunter (Department of Premier and Cabinet), Mike Kaiser (Department of Resources) and John Lee (Department of Tourism, Innovation and Sport) and (b) advise if each of the successful applicants were the recommendations of the panel(s)?

#### ANSWER:

#### Director-General, Department of the Premier and Cabinet

- (a) Rachel Hunter was appointed through an open merit recruitment process in accordance with The Merit Principle, Chapter 1, Part 4 of the *Public Service Act 2008* to the position of Director-General, Department of State Development, Manufacturing, Infrastructure and Planning on 16 March 2018.
