MR S O'CONNOR ASKED THE MINISTER FOR THE ENVIRONMENT AND THE GREAT BARRIER REEF AND MINISTER FOR SCIENCE AND YOUTH AFFAIRS (HON M SCANLON)—

# **QUESTION:**

Will the Minister provide (a) a breakdown of koala priority areas in each Local Government Area (LGA), by year they were established for the last two years, (b) the total land area protected in each of these LGAs and (c) any funding provided for koala protection for each area?

### **ANSWER:**

I thank the Member for the question.

The protection and management of koalas and habitat is critical for their long-term survival and this is an important focus of the Palaszczuk Government and the Department of Environment and Science in particular. Decisions that are based on science are the foundation for responsible management in order to protect koalas as well as balancing the needs of an expanding population.

On 7 February 2020, the Queensland Government commenced amendments to the planning framework, in relation to koala habitat protection, and released supporting koala habitat maps. The framework relies on two main data sets – the identification of core koala habitat through the Koala Habitat Areas (KHAs) (combined with Locally Refined Koala Habitat Areas (LRKHAs) from local governments) and the greater level of protection of koala habitat within the Koala Priority Areas (KPAs). Within these KPAs, clearing of core and locally refined koala habitat is prohibited subject to certain exemptions.

In order to provide certainty to landholders and businesses, the KPAs have not changed since their first release in early 2020. These areas will remain the same for the life of the South East Queensland Koala Conservation Strategy 2020-2025 (the Strategy) and will be reviewed in 2025, as part of the Strategy review. KHAs are amended annually to allow the Queensland Government to continue to accurately identify the best available koala habitat based on the latest data and science.

The following table is a breakdown of KPAs across the Local Government Areas (LGAs) and how much KHAs in hectares are within each LGA and within each KPA.
