MR J LANGBROEK asked the Minister for Children and Youth Justice and Minister for Multicultural Affairs (HON L LINARD)—

QUESTION

With reference to the Aboriginal and Torres Strait Islander Family Wellbeing Services, Walking with Family and answer to Question on Notice No. 596 of 2022—

Will the Minister advise for the last three years (a) the total cost of the program, (b) the individual allocation to each service provider and (c) the number of families assisted (reported separately by total and by each service) for each of the Family Well-being Service centres?

ANSWER

The Aboriginal and Torres Strait Islander Family Wellbeing Services provide support to First Nations families experiencing vulnerability to build their capacity to safely care for and nurture their children. This includes support for parents of unborn children to avert the need for intervention by the Department of Children, Youth Justice and Multicultural Affairs.

The following table provides information on the Aboriginal and Torres Strait Islander Family Wellbeing Services program for the last three years, including:

- a) the total cost of the program;
- b) the individual allocation to each service provider; and
- c) the number of families assisted (reported separately by total and by each service) for each of the Family Wellbeing Service centres.

Costs for services across regions can vary based on location and costs associated with service delivery such as travel and the delivery model.
