QUESTION:

With reference to WorkCover claims by teachers and staff—

Will the Minister provide for the 2022-23 financial year (reported separately by region, and by WorkCover claims lodged and accepted) (a) the total amount of WorkCover claims paid to teachers and to other staff for physical injury claims and psychological claims and (b) the number of WorkCover claims lodged by teachers and other school staff in Queensland State Schools?
