MR J LANGBROEK ASKED THE ATTORNEY-GENERAL AND MINISTER FOR JUSTICE, MINISTER FOR PREVENTION OF DOMESTIC AND FAMILY VIOLENCE (HON Y D'ATH)

QUESTION:

With reference to Native Title claims in Queensland—

Will the Attorney-General provide (a) the number of Native Title claims there are across the state and (b) a list of the Native Title claims?

ANSWER:

I am advised that there are 67 native title claims concerning land and waters within Queensland.

As at 19 September 2023, a public search of the National Native Title Tribunal's online database of native title applications reports there are 67 active native title applications in Queensland. Of the applications reported, I am advised that one application was in fact discontinued on 1 March 2023 and as such is no longer active.

However, a further application filed on behalf of the Tweed River Bundjalung People in New South Wales claims land within Queensland but is not included in the Tribunal's statistics for Queensland.

The 67 native title claims comprise the following types of applications made under the *Native Title Act 1993* (Cth):

- claimant applications, being claims brought by persons claiming to hold native title;
- compensation applications, being claims brought by persons seeking compensation for the effect of acts on their native title;
- revised native title determination applications, being an application brought to vary a previous determination; and
- non-claimant applications, being claims brought by persons who do not hold a native title interest.
