Ms F Simpson asked Premier and Minister for the Olympic and Paralympic Games (Hon. A Palaszczuk)—

QUESTION:

Will the Premier provide the number of SES band employees (reported separately by agency or department) as of March 2023?

ANSWER:

I am advised by the Public Sector Commission as follows.
