MR B HEAD ASKED MINISTER FOR TRANSPORT AND MAIN ROADS AND MINISTER FOR DIGITAL SERVICES (HON M BAILEY)—

QUESTION:

With reference to vehicle intercepts undertaken by Transport Inspectors for the period of 1 January 2022 to date—

Will the Minister advise how many intercepts have been undertaken each month (reported separately by Vehicle Registration Category i.e. articulated truck, bus, light commercial, passenger car etc)?

ANSWER:

I thank the Member for Callide for the question.

Between 1 January 2022 and 20 November 2023, the Department of Transport and Main Roads (TMR) undertook a total of 73,831 intercepts. A breakdown of the intercepts undertaken by TMR with reference to the Vehicle Registration Category is set out below.
