MR R MOLHOEK ASKED THE MINISTER FOR THE ENVIRONMENT AND THE GREAT BARRIER REEF, MINISTER FOR SCIENCE AND MINISTER FOR MULTICULTURAL AFFAIRS (HON L LINARD)—

QUESTION:

With reference to the \$1.1b Recycling and Jobs Fund announced on 11 December 2021-

Will the Minister (a) outline the total amount of the fund expended to date since it was announced, (b) provide a breakdown of funding allocated to individual projects (reported separately by project and region) and (c) detail the amount of funding expended on each project to date?

ANSWER:

I thank the Member for the question.

I am pleased to provide an update on the \$1.1 billion Recycling and Jobs Fund.

The Fund provides the vehicle to deliver a transformation of waste management and resource recovery across Queensland over a 10-year period.

The total amount expended by the Department of Environment and Science (DES) from 1 July 2022 to 31 October 2023 is \$57.8 million, noting that DES is not the only agency administering funding under the Recycling and Jobs Fund. The Department of State Development, Infrastructure, Local Government and Planning administers funding for industry development initiatives under the Fund.

The information below provides the funding allocated and expended by individual project and location from 1 July 2022 to 31 October 2023.
