MR B MICKELBERG ASKED MINISTER FOR TRANSPORT AND MAIN ROADS AND MINISTER FOR DIGITAL SERVICES (HON M BAILEY)—

QUESTION:

Will the Minister advise the numbers of apprentices and trainees directly employed by the Department of Transport and Main Roads as at the latest Queensland Public Sector workforce profile figures from 31 March 2023 (reported separately by vocational qualification)?

ANSWER:
