MR T MANDER ASKED THE MINISTER FOR HOUSING (HON M SCANLON)—

QUESTION:

With reference to the government's latest Social Housing Register figures as at 30 September 2023— Will the Minister advise (reported separately by Housing Service Centre) (a) how many households were removed from the Register in the September quarter and (b) how many people as part of those households were removed from the Register?

ANSWER:

The Queensland Government's social housing register is a point-in-time register of eligible social housing applicants.

Over the 12 months to 30 June 2023, over 5,000 households were assisted into social housing. From 1 July to 30 September 2023, 848 new households have been assisted.

Applicants on the social housing register can apply and access the department's full range of housing products and services or be referred to other agencies to help with immediate housing and support needs.

The Department of Housing regularly reviews applicants' circumstances and eligibility for social housing through well-established housing register management practices. Applications are removed from the register for a variety of reasons, including acceptance of social housing, change in household circumstances or eligibility requirements, or cases where a household's housing needs have been met by another product or service and they have advised they no longer require social housing.

There were 40 applications (69 people) for the Bayside Housing Service Centre that were on the register as at 30 June 2023 that were not on the register as at 30 September 2023.

There were 77 applications (146 people) for the Mackay Housing Service Centre that were on the register as at 30 June 2023 that were not on the register as at 30 September 2023.

There were 134 applications (235 people) for the Maroochydore Housing Service Centre that were on the register as at 30 June 2023 that were not on the register as at 30 September 2023.

There were 160 applications (237 people) for the Maryborough Housing Service Centre that were on the register as at 30 June 2023 that were not on the register as at 30 September 2023.

There were 150 applications (282 people) for the Moreton Bay Housing Service Centre that were on the register as at 30 June 2023 that were not on the register as at 30 September 2023.
