## Question on Notice No. 458 Asked on 20 April 2023

MR P WEIR ASKED MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR FIRE AND EMERGENCY SERVICES (HON M RYAN)—

## QUESTION:

Will the Minister provide for the Cambooya, Crows Nest, Drayton, Goombungee, Jondaryan, Oakey, and Pittsworth Police Stations from 2013 to 2023 inclusive by years, (a) the number of police officers allocated, (b) the length of time taken to fill each position vacant and (c) the length of time each officer was stationed at each of the listed locations?

## ANSWER:

a. I am advised by the Queensland Police Service (QPS) that the number of approved permanent positions for each requested Police Division, for each financial year from 2012–13 to 2021–22 inclusive is detailed below. The relevant data for the 2022–23 financial year will be available at the end of the financial year.
