**DR C ROWAN** ASKED MINISTER FOR EDUCATION, MINISTER FOR INDUSTRIAL RELATIONS AND MINISTER FOR RACING (HON G GRACE)

### QUESTION:

Will the Minister detail from 2015 to 2023 to date, the number of WorkCover Claim Forms that have been submitted to WorkCover Queensland, due to possible or actual exposure to Asbestos in Department of Education Facilities, reported separately by claim (medical expenses only, medical expenses and time off, report purposes only, other) and including the date that each incident/injury occurred?

### ANSWER:

For the time period of July 2014 to 2023 to date, the number of workers' compensation claims forms that have been lodged to WorkCover Queensland (WorkCover) due to possible or actual exposure to asbestos in Department of Education facilities is 132.

These policies cover the department's workers but do not cover other individuals who may be exposed to asbestos while undertaking work on the department's facilities, such as contracted tradespersons or asbestos removalists.
