MR S O'CONNOR ASKED THE MINISTER FOR THE ENVIRONMENT AND THE GREAT BARRIER REEF, MINISTER FOR SCIENCE AND MINISTER FOR MULTICULTURAL AFFAIRS (HON L LINARD)—

QUESTION:

With reference to the Reef protection regulations—

Will the Minister provide all FTE filled positions in compliance roles (reported separately by month (or nearest reporting period) and region) since the implementation of the current Act?

ANSWER:

I thank the Member for the question.

The Department of Environment and Science's reef compliance program has been one of the activities under the Queensland Reef Water Quality Program and commenced during the 2015-16 financial year.

Since the strengthened Reef protection regulations under the *Environmental Protection Act 1994* came into effect on 1 December 2019, the department has restructured the compliance program to implement compliance activities for the newly regulated commodities and regions.

The strengthened Reef protection regulations have had a phased commencement in different reef regions and for different commodities over three years for sugarcane and banana producers and beef cattle grazing farms in the Wet Tropics, Burdekin, Mackay Whitsunday, Fitzroy, and Burnett Mary regions.

The full-time equivalents (FTEs) dedicated to the compliance program have been increasing over time to reflect the changes to the regulated commodities and regions. Compliance officers are dispersed across the office locations of Cairns, Townsville, Mackay, Rockhampton and Brisbane in order to service the different reef regions. The department is continuing to undertake recruitment for suitable officers to undertake agricultural compliance.

There are currently 30.35 FTEs appointed in the compliance program and recruitment is ongoing. The number of filled FTEs in each office location by month since December 2019 reported below is based on data from the Aurion human resources and payroll software used by the department.

The database assigns filled positions to an office location; however, there will be circumstances where the compliance officer may be working from another office location in any given month due to operational demands or backfilling short term vacancies or to accommodate flexible work arrangements.
