# Question on Notice No. 858

### Asked on 16 June 2023

**DR C ROWAN** ASKED MINISTER FOR EDUCATION, MINISTER FOR INDUSTRIAL RELATIONS AND MINISTER FOR RACING (HON G GRACE)

#### QUESTION:

Will the Minister provide from 2019 to 2023-to-date (reported separately by region) (a) the number of Department of Education-owned housing properties and (b) the number of properties rented by the Department of Education for the purpose of housing teachers and school staff?

#### ANSWER:

The Department of Education (DoE) provides housing solutions to support schools to deliver teaching and learning to Queensland students in three ways:

- DoE uses its own portfolio of housing infrastructure;
- properties are leased from the Department of Energy and Public Works (DEPW); and
- properties are leased from the private market.

Details of the number of units of accommodation used for the purpose of education housing from the 2018–19 to 2022–23 financial years by education region are at **Attachment 1**.

Over time there have been changes to the size of the DoE portfolio, resulting mainly from the previous government's decision that the management and ownership of Government Employee Housing (GEH) was to be centralised and managed by the former Department of Housing and Public Works from 1 July 2014.

Since 2014 there have been transitions of stock to GEH, the most recent being in 2021.

In 2023–24, the Queensland Government is investing \$48.3 million over four years (2023–24 to 2026–27) to meet emergent housing requirements in remote and regional communities. This is in addition to \$10 million allocated for housing acquisitions in 2022–23.
