MR S MINNIKIN ASKED MINISTER FOR TRANSPORT AND MAIN ROADS (HON M BAILEY)—

QUESTION:

With reference to the Department of Transport and Main Roads database containing vehicle registration and ownership information—

Will the Minister advise (a) the names of each of the commercial entities that are currently able to access data from the database and the date that they were first granted access and (b) the total revenue generated for the department from the provision of database data to commercial entities (reported separately for each of the last three financial years)?

ANSWER:

I thank the Member for Chatsworth for the question.

As of 23 February 2023, there were 374 commercial entities—including lawyers, insolvency entities and insurance entities—approved to access data from the Department of Transport and Main Roads' (TMR) register of motor vehicles. Below is a list of those commercial entities and the date that each was first granted access to the register.
