MR D JANETZKI ASKED MINISTER FOR POLICE AND COMMUNITY SAFETY (HON M RYAN)—

QUESTION:

Will the Minister advise the number and type of reported offences (offences against the person/offences against property/other offences) actioned against persons aged 10 to 17 years (reported separately by year and suburb) in the Toowoomba Police Division for the past five years?

ANSWER:

I am advised by the Queensland Police Service the number of offences actioned against persons aged 10 to 17 years for each suburb in the Toowoomba Police Division are detailed below:

- 4. These figures do not represent an offender count but represents a count of reported offences that have been actioned during the reporting period.
- 5. Actions against juveniles include Arrest, Cautions, Community Conference, Notice to Appear, Summons, Warrant and Other.
- 6. Data for suburbs are non-standard boundaries and should be treated as an estimate only.
- 7. Suburb boundaries may span parts of Toowoomba Division and surrounding police divisions. Figures relate to parts of the suburb within Toowoomba Division only.
- 8. Suburbs where there are no reported offences actioned against juvenile offenders in the period have been excluded.
- 9. Please note that in this table, any value shown as '< 5' represents a number less than 5, which has been anonymised for confidentiality reasons.
