MR S O'CONNOR asked the Minister for State Development and Infrastructure, Minister for Industrial Relations and Minister for Racing (HON G GRACE) –

QUESTION:

With reference to the \$1.1b Recycling and Jobs Fund announced on 11 December 2021—

Will the Minister (a) outline the total amount of the fund expended by the Department of State Development to date since it was announced, (b) provide a breakdown of funding allocated to individual projects (reported separately by project and region) and (c) detail the amount of funding expended on each project to date?

ANSWER:

The Department of State Development and Infrastructure (DSDI) has been allocated (from 1 July 2022 to 30 June 2027) \$175.2 million from the Recycling and Jobs Fund for industry development activities.

One activity included in the funding provided to DSDI is the \$10 million 'Remade In Queensland' program which was announced on 12 January 2024. This funding has been transferred to the Department of Regional Development, Manufacturing and Water.

Of the remaining funds the total amount allocated by DSDI to industry development activities is \$28,041,675, with \$7,697,076 expended. Funds are allocated and expended in line with industry applications and completion of project delivery milestones.

This is contributing to delivery of the Resource Recovery Industry Development Program (RRIDP) and its successor, the Queensland Recycling Modernisation Fund (QRMF). The total amount of funds allocated to individual projects (reported separately by project and region) from 1 July 2022 to end February 2024 is listed below:

The QRMF is being delivered in partnership with the Australian Government who contribute an equal amount of funding and expenditure.

The remaining \$137.2 million from the Recycling and Jobs Fund will be allocated to industry development activities currently being planned.
