MS R BATES ASKED MINISTER FOR HEALTH, MENTAL HEALTH AND AMBULANCE SERVICES AND MINISTER FOR WOMEN (HON S FENTIMAN)—

QUESTION

With reference to answer to Question on Notice No. 598 of 2023—

Will the Minister advise (reported separately for each Hospital listed on the 'Hospital Performance' website - <https://www.performance.health.qld.gov.au/>) the dollar value of capital maintenance work required at each facility?

ANSWER

Queensland Health is committed to ensuring that all its facilities provide a safe environment for patients, staff, and visitors. Queensland Health complies with the whole-of-government *Queensland Government Building Policy Framework - Growth and Renewal*, which requires all buildings to be assessed by site inspection at least every three years, depending on the nature of the facility.

Maintenance items identified during the inspections are risk assessed to ensure that required maintenance, which addresses potential risk to patient safety, is progressed for immediate action.

Other items that can be safely deferred are scheduled over the forward years. Each Hospital and Health Service reports on their deferred maintenance in their annual reports, which can be found at the following locations:
