Question on Notice No. 1046 Asked on 17 September 2025

MS W BOURNE ASKED MINISTER FOR POLICE AND EMERGENCY SERVICES (HON D PURDIE)—

QUESTION:

Will the Minister advise since 13 December 2024, (a) how many children aged 10-17 (inclusive) have been refused police bail, refused court bail, or refused bail altogether for 'Adult Crime, Adult Time' offences compared to other offences not accompanied by an 'Adult Crime, Adult Time' offence,(b) these figures reported separately for (i) First Nations children, (ii) non-Indigenous children, (iii) children aged 10-13 and (iv) children aged 14-17 and (c) what is the equivalent data for the same date range 12 months earlier?

ANSWER:

I am advised by the Queensland Police Service that the number of charges where police bail was refused by 'Adult Crime, Adult Time' offences comparing non-'Adult Crime, Adult Time', offences are detailed the following tables.

 3. Non "adult crime, adult time" offences refer to charges not in the above list.
- 4. Data relates to police bail being refused as recorded in police systems.
- 5. Bail is assumed to be refused if one of the conditions apply to each individual charge:
 - (a) charge that is linked to a custody report has a detention log entry type of 'bail denied'; or
 - (b) proceeding type on the charge sequencing report linked to the charge is 'bail refused'.
- 6. Charges where bail is not refused, are not linked to a charge sequencing report, or charges without a linked custody report are not included in counts.
- 7. Data refer to offenders aged 10 to 17 years only.
- 8. Persons whose age cannot be determined has been excluded from counts.
- 9. Data refers to the period from 13 December 2023 to 31 August 2024, and 13 December 2024 to 31 August 2025 only. Charges outside of those periods are excluded.

The Attorney-General and Minister for Justice and Minister for Integrity is best placed to respond to the part of the question asked related to court bail and refused bail altogether.
