HON M SCANLON ASKED MINISTER FOR POLICE AND EMERGENCY SERVICES (HON D PURDIE)—

QUESTION:

With reference to Justice, Integrity and Community Safety Committee Estimates 2025 Pre-Hearing Question on Notice No. 3—

Will the Minister advise separately the number of unique juveniles charged with an offence specified under s175A of the Youth Justice Act 1992 that were (a) Aboriginal or Torres Strait Islander and (b) non-Indigenous, with each of (a) and (b) reported separately by (1) age groups (i) 10-13 and (ii) 14-17 and (2) the following time periods – (i) 2023-24 financial year, (ii) 2024-25 financial year, (iii) July 2025 and (iv) August 2025?

ANSWER:

I am advised by the Queensland Police Service that the number of unique juveniles charged with an offence specified under s175A of the Youth Justice Act 1992 for persons between 10 to 13 and 14 to 17, for financial year 2023-24, financial year 2024-25, July 2025 and August 2025 is detailed in the following tables:
