MR S KING ASKED MINISTER FOR POLICE AND EMERGENCY SERVICES (HON D PURDIE)—

QUESTION:

With reference to the Queensland Disaster Management Training Framework—

Will the Minister advise the Chairperson and Members of the State Disaster Management Group (SDMG) who have (a) completed the mandatory training/induction (reported separately by chairperson, member and the date the induction was completed) and (b) not yet completed the mandatory training/induction and when this induction is scheduled (reported separately by chairperson, member and the date training and/or induction is scheduled)?

ANSWER:

I am advised by the Queensland Police Service (QPS) that the members of the State Disaster Management Group (SDMG) are also members of the Queensland Disaster Management Committee (QDMC) with the induction process for each being identical.

Queensland Disaster Management Arrangements training is available via an online platform or alternatively by face-to-face delivery. Once training has been completed the Secretariat completes the induction with the member.

As such, I am advised by the QPS that the details of members of the SDMG who are required to complete mandatory training/induction, and the dates on which training/induction was completed, are outlined in the table below:
