1 Community Support and Services Committee

The Community Support and Services Committee (committee) is a portfolio committee of the Legislative Assembly which commenced on 26 November 2020 under section 88 of the *Parliament of Queensland Act 2001* (PoQA) and the Standing Rules and Orders of the Legislative Assembly.¹

- The committee's areas of portfolio responsibility are:
- Communities, Housing, Digital Economy and the Arts
- Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships
- Children, Youth Justice and Multicultural Affairs.

In addition, the committee has a monitor and review function in relation to the performance of the functions of the Family Responsibilities Commission.

Sections 93(1) and 93(3) of the PoQA provides that a portfolio committee is responsible for examining each bill and item of subordinate legislation in its portfolio areas to consider:

- the policy to be given effect by the legislation
- the application of fundamental legislative principles
- matters arising under the *Human Rights Act 2019* (HRA)
- for subordinate legislation – its lawfulness.²

Portfolio committees also have responsibility for scrutiny of public accounts and public works which relate to their portfolio. Committees also consider reports of the Auditor-General and other referrals from the Legislative Assembly and may initiate an inquiry into any other matter they consider appropriate.

2 Annual report

In accordance with section 108 of the PoQA, the committee is required to table an annual report within 4 months and 14 days after the end of each financial year. The report must include:

- a list of meetings of the committee and the names of members attending or absent from each meeting
- a summary of issues considered by the committee, including a description of the more significant issues arising from the considerations
- a statement of the committee's revenue and spending for the year
- a brief description of responses by Ministers to recommendations of the committee.

This report provides a summary of the activities of the committee from 1 July 2021 to 30 June 2022.

3 Inquiries and reports

The committee considered a series of bills, subordinate legislation and referred inquiries during the 2021-22 financial year, as well as reporting on its annual activities.

Overall, the committee tabled 13 reports across the year.³ Copies of these publications are available from the committee's webpage.⁴

3.1 Bills and subordinate legislation

The committee examined 7 bills and 10 pieces of subordinate legislation in accordance with its responsibility under section 93(1) of the PoQA, and tabled 7 bill reports and 3 subordinate legislation reports, as outlined below.

In examining this proposed legislation, the committee considered:

- the policy to be given effect by the legislation
- the application of fundamental legislative principles to the legislation
- the compatibility of the proposed legislation with the HRA, including considering the compatibility statement and human rights certificate tabled with bills and subordinate legislation respectively, and
- for subordinate legislation – its lawfulness.

3.2 Examination of Bills

3.2.1 Report No. 7 – Housing Legislation Amendment Bill 2021

On 18 June 2021 (in the previous financial year), the Housing Legislation Amendment Bill 2021 was referred to the committee with a reporting date of 6 August 2021. The committee simultaneously considered the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021, which covered similar subject matter to the Bill.

The committee received and accepted 900 individual submissions, 1 campaign submission, and 9 form submissions with a total of 1,411 form submissions.

On 7 July 2021, the committee received a written briefing on the Bill from the department of Communities, Housing and Digital Economy, and held a public briefing with officers of that department on 12 July 2021. The committee held a public hearing on 20 July 2021.

The committee tabled its report on the extended reporting date⁵ of 16 August 2021, recommending the Bill be passed. The committee made 5 recommendations. The government supported all recommendations.⁶

The Bill was passed with amendments on 14 October 2021.

3.2.2 Report No. 8 – Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021

On 26 May 2021 (in the previous financial year), the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021 was referred to the committee with a reporting date of 26 November 2021. The committee simultaneously considered the Housing Legislation Amendment Bill 2021 which covered similar subject matter to the Bill and

determined to align key dates in relation to the examination of both bills, including the reporting dates for the bills.

In addition to the activity reported on in the committee's 2020-21 annual report, the committee received and accepted 900 individual submissions and 1,436 form submissions. The committee held a public hearing on 20 July 2021.

The committee tabled its report on 16 August 2021, recommending the Bill not be passed.

The bill was discharged from the Notice Paper on 14 October 2021 under Standing Order 87.

3.2.3 Report No. 9 – 2021-22 Budget Estimates and Volume of Additional Information

On 15 June 2021 (in the previous financial year), the Appropriation (Parliament) Bill 2021 was introduced and referred to the committee for its examination and report on the 2021-22 portfolio budget estimates within the committee's areas of responsibility, as set out under Schedule 6 of the Standing Orders.

The committee held a public hearing on 13 August 2021 at which it questioned the following Ministers regarding the proposed expenditure for their portfolio areas:

- Minister for Communities and Housing, Minister for Digital Economy and Minister for the Arts
- Minister for Seniors and Disability Services and Minister for Aboriginal and Torres Strait Islander Partnerships
- Minister for Children and Youth Justice and Minister for Multicultural Affairs.

The committee tabled its report, together with a Volume of Additional Information, on 20 August 2021, recommending that the portfolio expenditures as proposed in the bill be agreed to by the Legislative Assembly without amendment.

The bill was passed on 1 September 2021.

3.2.4 Report No. 12 – Child Protection Reform and Other Legislation Amendment Bill 2021

On 15 September 2021, the Child Protection Reform and Other Legislation Amendment Bill 2021 was introduced and referred to the committee for examination and report by 12 November 2021.

The committee received a written briefing on the bill on 23 September 2021 and held a public briefing with officers from the Department of Children, Youth Justice and Multicultural Affairs and the Department of Justice and Attorney-General on 27 September 2021.

The committee received and accepted 18 submissions on the Bill. The committee held public hearings to hear from stakeholders in Brisbane, Mt Isa, Cairns, and Thursday Island on 15, 18, 19, 20 and 21 October 2021 respectively.

The committee tabled its report on 12 November 2021 recommending the Bill be passed. The committee made 3 recommendations. The government supported all recommendations.⁷

This bill passed on 10 May 2022.

3.2.5 Report No. 15 – Public Trustee (Advisory and Monitoring Board) Amendment Bill 2021

On 28 October 2021, the Public Trustee (Advisory and Monitoring Board) Amendment Bill 2021 was introduced and referred to the committee for examination and report.

The committee received a written briefing on the bill from the Department of Justice and Attorney-General on 10 November 2021 and held a public briefing with officers from that department on 15 November 2021. The committee received and accepted 10 submissions on the bill. The committee held a public hearing on 29 November 2021 to hear from stakeholders.

The committee tabled its report on the bill on 21 January 2022, recommending that the bill be passed. The committee made 3 recommendations. The government accepted all recommendations.⁸

This bill passed on 11 May 2022, with amendments.

3.2.6 Report No. 16 – Criminal Law (Raising the Age of Responsibility) Amendment Bill 2021

On 15 September 2021, the Criminal Law (Raising the Age of Responsibility) Amendment Bill 2021 and referred it to the committee for examination and report.

The committee received a total of 76 individual submissions and 228 form submissions.

The committee held a public briefing with Mr Michael Berkman MP, Member for Maiwar, on 15 November 2021. The committee held a public hearing on 14 February 2022.

The committee tabled its report on the bill on 15 March 2022, recommending the bill not be passed.

The committee made 5 recommendations. The government accepted all recommendations.⁹

3.2.7 Report No. 17 – Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022

On 22 February 2022, the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022 was introduced and referred to the committee for examination and report.

The committee received and accepted a total of 4,188 submissions comprising 1,762 individual submissions and 2,427 form submissions.

The committee received a written briefing on the bill from Queensland Health on 1 March 2022. The committee held a public briefing with the Department of Health on 7 March 2022.

The committee held a public hearing on 14 March 2022.

The committee tabled its report on the bill on 25 March 2022, recommending that the bill be passed.

The bill was passed on 31 March 2022.

3.3 Examination of subordinate legislation

During the reporting period, the committee examined 10 pieces of subordinate legislation in accordance with its responsibility under section 93(1) of the PoQA, tabling the following reports:

- Report No. 10, 57th Parliament – Subordinate legislation tabled between 24 February 2021 and 25 May 2021 (tabled on 23 August 2021)
- Report No. 13, 57th Parliament – Subordinate legislation tabled between 26 May 2021 and 31 August 2021 (tabled on 12 November 2021)
- Report No. 18, 57th Parliament – Subordinate legislation tabled between 1 September 2021 and 15 March 2022 (tabled on 1 April 2022).

3.3.1 Compliance with the *Legislative Standards Act 1992*

The committee identified no issues regarding the subordinate legislation's consistency with fundamental legislative principle or its lawfulness.

For each of the examined items of subordinate legislation, the committee was satisfied that the explanatory notes complied with the requirements of part 4 of the LSA.

3.3.2 Compliance with the *Human Rights Act 2019*

From 1 January 2020, all subordinate legislation was required to be accompanied by a human rights certificate prepared and tabled with the subordinate legislation by the responsible Minister.¹⁰

During the year, the committee examined the human rights certificates for all items of subordinate legislation notified and tabled,¹¹ including considering the explanations provided by responsible Ministers regarding any identified limitations on human rights, and the compatibility of the subordinate legislation with the HRA.

Report No. 13 highlighted human rights issues potentially raised by items of subordinate legislation discussed within the reports, all of which were acknowledged by the responsible Minister in the relevant human rights certificate. In each instance, the committee was satisfied with the explanation provided by the Minister in the relevant human rights certificate, and agreed that any limitation on human rights was reasonable and demonstrably justifiable in the circumstances.

The committee also considered that the human rights certificates tabled with these items of subordinate legislation provided a sufficient level of information to facilitate understanding of the subordinate legislation in relation to its compatibility with human rights.

3.4 Referred inquiries

Section 92 of the PoQA provides that, in addition to performing a legislative scrutiny and general oversight role in relation to its primary areas of responsibility, a portfolio committee is responsible for dealing with any issue referred to it by the Legislative Assembly or under another Act.

During 2021-22, one issue-based inquiry was referred to the committee by the Legislative Assembly. The committee's inquiry activities are set out below.

3.4.1 Inquiry into social isolation and loneliness in Queensland

On 27 May 2021, the Legislative Assembly agreed to a motion that the committee inquire into and report on social isolation and loneliness in Queensland. The terms of reference for the inquiry are that the committee inquire into and report on:

- the nature and extent of the impact of social isolation and loneliness in Queensland, including but not limited to:
 - identification of and consultation with vulnerable and disadvantaged individuals or groups at significant risk across the life course
 - the interplay of COVID-19 with this issue
- the causes and drivers of social isolation and loneliness, including those unique to Queensland
- the protective factors known to mitigate social isolation and loneliness

- the benefits of addressing social isolation and loneliness, examples of successful initiatives undertaken nationally and internationally and how to measure social isolation and loneliness in Queensland to determine if implemented strategies are effective
- how current investment by the Queensland Government, other levels of government, the non-government, corporate and other sectors may be leveraged to prevent, mitigate and address the drivers and impacts of social isolation and loneliness across Queensland, including:
 - services and programs such as health and mental health, transport, housing, education, employment and training, sport and recreation, community services and facilities, digital inclusion, volunteering, the arts and culture, community development, and planning for accessible, inclusive and connected communities
 - targeted support to vulnerable and disadvantaged groups and those most at risk
- the role, scope and priorities of a state-wide strategy to address social isolation and loneliness, considering interactions with existing Queensland and national strategies.

The committee received and accepted 169 submissions, including one video submission.

The committee received written advice from 16 departments in response to the terms of reference of the inquiry, including:

- Department of Children, Youth Justice and Multicultural Affairs (DCYJMA)
- Department of Communities, Housing and Digital Economy (DCHDE)
- Department of Education
- Department of Employment, Small Business and Training
- Department of Environment and Science
- Department of Justice and Attorney-General
- Department of Regional Development, Manufacturing and Water
- Department of Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships (DSDSATSIP)
- Department of State Development, Infrastructure, Local Government and Planning
- Department of the Premier and Cabinet
- Department of Tourism, Innovation and Sport (DTIS)
- Department of Transport and Main Roads
- Queensland Corrective Services
- Queensland Health
- Queensland Police Service
- Queensland Treasury.

The committee received public briefings about the inquiry from DCHDE, Queensland Health, DCYJMA, DSDSATSIP, Department of Transport and Main Roads, Department of Education, and DTIS.

The committee held public hearings on the following dates to hear from stakeholders in the locations listed below:

- Brisbane, 13 September 2021 and 11 October 2021
- Mount Gravatt, 28 September 2021
- Toowoomba, 29 September 2021

- Nambour, 30 September 2021
- Mount Isa, 18 October 2021

- Thursday Island, 21 October 2021.

The committee tabled its report, Report No. 14, 57th Parliament, *Inquiry into social isolation and loneliness in Queensland*, on 6 December 2021. The committee report was noted in the Legislative Assembly as per the committee's Recommendation 1 on 31 March 2022. The committee made 13 other recommendations. The government supported all the recommendations.¹²

4 Consideration of Auditor-General reports

During the reporting period, the committee was referred one Auditor-General report, in accordance with Standing Order 194B.

4.1 Auditor-General Report 1: 2020-21 – Family Support and Child Protection System

The committee continued its inquiry into Auditor-General Report No. 1: 2020-21 – *Family support and child protection system* (Report No. 1: 2020-21).

On 20 June 2022, the committee resolved to follow up on the implementation of the Auditor-General's recommendations in accordance with commitments for implementation from the following relevant public entities:

- Department of Children, Youth Justice and Multicultural Affairs
- Department of Premier and Cabinet
- Queensland Health
- Department of Education
- Queensland Police Service
- Queensland Family and Child Commission
- Office of the Public Guardian.

As at 30 June 2022, the committee's consideration of Report 1: 2020-21 was ongoing.

5 Monitoring and oversight

The committee has responsibility under Standing Order 194A for oversight of the Family Responsibilities Commission (FRC). The committee's role is to:

- to monitor and review the performance by the FRC of the FRC's functions
- to report to the Legislative Assembly on any matter concerning the FRC, the FRC's functions or the performance of the FRC's functions that the committee considers should be drawn to the Legislative Assembly's attention
- to examine the annual report of the FRC tabled in the Legislative Assembly and, if appropriate, to comment on any aspect of the report

- to report to the Legislative Assembly any changes to the functions, structures and procedures of the FRC that the committee considers desirable for the more effective operation of the FRC or the *Family Responsibilities Commission Act 2008* (FRC Act).¹³

5.1.1 Oversight activities during 2021-22

During the financial year, the committee considered the FRC's 2020-21 annual report, which was tabled on 1 February 2022. Following its consideration of that report, to assist the committee with its oversight of the functions of the FRC, the committee held a public briefing with the Family Responsibilities Commissioner, Ms Tammy Williams, and other FRC staff, on 28 March 2022.

Following the public briefing on 29 March 2022, the committee wrote to the Minister for Seniors and Disability Services and Minister for Aboriginal and Torres Strait Islander Partnerships regarding information sharing arrangements between the Department of Education and the FRC in relation to school attendance notices under section 40 of the FRC Act, and the availability of attendance figures for schools in the Welfare Reform Communities. At that time, the committee also wrote to the Minister for Children and Youth Justice and Minister for Multicultural Affairs regarding the provision of Children's Court advice notices to the FRC.

6 Consideration of matters within portfolio

In relation to the committee's portfolio area, the committee may consider a matter, report on the matter, and make recommendations to the Legislative Assembly.¹⁴

6.1 Provision of social housing

On 28 March 2022, the committee resolved to conduct a study tour in Sydney and Melbourne in June 2022 to inform the committee of innovative models for the provision of public and social housing, as part of an investigation into:

- funding models used to finance public and community housing
- initiatives to address homelessness
- initiatives to house seniors, including women.

The committee received written advice from the Australian Department of Social Services and DCHDE. The committee also held a public briefing with these entities on Monday 15 August 2022.

The committee tabled its Report No. 20, 57th Parliament - *Exploring models of housing in Australia's two largest capital cities: Sydney and Melbourne 2022* on Friday 9 September 2022.
