This section applies if a local government makes an application to the Minister under section 20C 4 in relation to a remote primary school and the 5 Minister declines to extend the education 6 provided at the school.

- (2) The chief executive and the local government 8 must establish a remote secondary learning 9 facility for years 7 to 10 in the town in which the 10 remote primary school is located.
- (3) The purpose of a remote secondary learning 12 facility is to support students enrolled in a 13 program of distance education for years 7 to 10 14 through tutoring by teacher aides.
